




### 99 Mph Winds Cause Damage, Expenses For Repairs

Some of the highest winds ever recorded on Cheyenne Mountain hit Enclave Estates back in January causing damage to roof tiles and stucco on our peripheral fence surrounding the neighborhood. Repairs have been completed in both areas and the neighborhood is back to normal. This event demonstrates our continuing need to maintain adequate reserves to meet these unexpected damages.





#### **Deck Painting Reminder**

Please check your deck surface to make sure it is properly maintained by being painted every 2-years. The HOA paints & maintains the exterior of your deck but the deck surface maintenance falls to the homeowner.

The recommended color stain is Sherwin Williams Yankee Barn, SW3505 or equivalent.

One of our neighbors advises that this exact color is no longer available but that the local Sherwin-Williams Paint Store at 1815 S. Nevada Ave. (719-475-1710) can provide an equivalent stain.

# The Ridges Workforce Housing Project In Second Review With City

A 60 apartment project consisting on 1, 2, and 3 bedroom units in 3-buildings is being proposed by Commonwealth Development of Wisconsin on a 3.7 acre site located at 4375 Broadmoor Bluffs Drive behind Safeway. The project would be managed by Greccio Housing of Colorado Spring, a local non-profit organization. Renter would need to be employed and would have incomes from \$24K to \$36K per year. Development would start in 2017 with completion planned by 2018.





Commonwealth purchased the property for \$1.2M in 2016 and has received \$11M in federal low-income housing tax credits for a development estimated at \$14M. The project is currently in its second review with City Planning.
